


Subject : Regarding issuance of Recognition Certificate to the Schools under Sub-Rule (4) of Rule 11 of Right of Children to Free and Compulsory Education Rules, 2011 for the purposes of Section 18 of Right of Children to Free and Compulsory Education Act 2009.

With reference to your application for session 2022-23 on the captioned subject and on the basis of correspondence/inspection of the school made thereafter in this reference, I Rohini Kumbhar, Education Officer (Pri), Zilla Parishad, Nagpur grants the provisional recognition to the school **Lakhotiya Bhutada High School CBSC Kondhali, Tah.Katol, Dist.Nagpur (Medium-English)** for Standard I to 8 for the period of three years from 01/04/2022 to 31/03/2025.

The above recognition is subject to the compliance of following conditions: -

- 1) The period of recognition will not be extended in any case. It will not be obligatory to grant recognition or affiliation after standard Eighth.
- 2) The school will follow the provisions contained in Right of Children to Free and Compulsory Education Rules, 2011 (Annexure two)
- 3) The admission to the children from weaker section and deprived section near the school will be given in Standard - 1 to the extent of minimum 25% of the number of students in that standard and they will be given free and compulsory education till the completion of primary education. Provided further that this norm will be complied with even in respect of pre-primary standards.
- 4) As regards the children specified in paragraph 3, the reimbursement will be received in accordance with Section 12(2) of the school act. The separate Bank Account will be given to the school for getting such reimbursement.
- 5) The Society/School will not recover any capitation fee nor will constrain the child or his/her mother/father for any of scrutiny procedure.
- 6) No any child will be refused admission to the school for want of proof of age or for any reason like religion, caste or race, place of birth.
- 7) (One) No any children admitted in the school will be detained in the same standard in which standard he/she is or will not be removed from the school till the completion of primary education
(Two) No physical punishment or mental torture should be caused to any of the child.
(Three) Till the completion of primary education, it will not be necessary for any child to pass the examination of any of the board.
(Four) Every child completing primary education will be issued the certificate prescribed vide Rule 23.
(Five) The handicapped/special needy students will be included in accordance with the act.
(Six) The appointment of teacher holding minimum qualification prescribed under section 23(1) of the act will be made. Provided further that, the teachers not holding the minimum qualification on the date of commencement of the Act must acquire such minimum qualification with a period of 5 years.
(Seven) The teacher will perform his/her duties specified in Section 24(1) of the Act, and
(Eight) The school shall ensure that the teacher/lady teacher is not involved in private tuitions




8. The school will follow the syllabus prepared by the appropriate authority

- 11) The classes or sections having no recognition cannot be run on the name of school within vicinity of the school or anywhere
- 12) The building or other structure or playground of the school will be used only for education or skill development purpose.
- 13) The school is being run through the Society registered under the society registration act 1860 (21 of 1860) or the Bombay Public Trust Act 1950.
- 14) The school is not being run for benefit or gaining profit of any person, group or group of persons or any of person.
- 15) The accounts of the school should be got audited and certified from the Chartered Accountant and should prepare the appropriate Account Statements in accordance with the Rules. One copy of each account statement should be sent to the District Education Officer every year.
- 16) The recognition Index number given to your school is **27090209013** and it should be mentioned while making any correspondence with this office which please note.
- 17) The school should submit such reports and information which will be demanded by the Director of Education, District Education Officer from time to time and should follow the instructions which will be issued by the government or local authorities for regular compliance of the conditions of school recognition or removing the lacunas in the working of the school.
- 18) It should be ensured that the renewal is made in case any renewal of registration of the society is due.
- 19) The aforesaid lacunas under the Right of Children to Free and Compulsory Education Act 2009 should be removed by the school till 31.03.2025 failing which, the recognition of your school shall automatically stand cancelled.
